Ambassador Raphael Naegeli was born on 29 September 1969 in Zurich, Switzerland.

He attended schools in Zurich and graduated in 1996 with a Master of Philosophy after studies in History, Economy and History of Eastern Europe at University of Zurich and Free University Berlin.

Following professional experiences in journalism and banking he started his diplomatic career 1998 at the Office of European Integration within the Swiss Federal Department of Foreign Affairs. Subsequently he was posted at the Embassies in Sarajevo and Budapest and from 2002-2004 as first collaborator of the Swiss Embassy Sarajevo.

With his return to Bern 2004 he became head of policy planning unit at the Human Security Division of the FDFA. Seconded to the International Civilian Office, a supervisory body for the newly independent state of Kosovo he headed its Unit for Minority Integration from 2008-2011.

Returning to Bern in 2011 Raphael Naegeli first became Regional Coordinator for Southeastern Europe, 2012 Deputy Head in the rank of a Minister and 2015 Head of the Task Force for the Swiss OSCE Chairmanship.

From August 2016 to August 2018 Raphael Naegeli was Deputy Head of the Human Security Division of the FDFA with rank of Minister. Since August 2018, Ambassador Raphael Naegeli is Assistant State Secretary for Asia/Pacific in the Swiss Federal Department of Foreign Affairs.

Ambassador Raphael Naegeli speaks German, French, English, Italian, Russian and Serbian/Croatian. He is married and has two children.

#### **Stefan Kohler, Partner, VISCHER AG**



Stefan Kohler has extensive experience in IP/technology law and regulated markets such as healthcare, pharma, medtech, biotech, cosmetics and food-stuffs. He regularly represents Swiss and foreign companies before Swiss courts and administrative authorities. He first studied science at the ETH in Zurich with a focus on molecular biology. Stefan is an associate judge at the Swiss Federal Patent Court, president of the Licensing Executives Society Switzerland (LES-CH) and lecturer at the Swiss Institute for Intellectual Property in the field of licensing agreements, R&D agreements and technology transfer.

#### **Dr. William Pao, Head of Pharmaceutical Research & Early Development, Roche**



Dr. William Pao is the Head of Roche's Pharmaceutical Research & Early Development (pRED) unit, headquartered in Basel, Switzerland, and a member of Roche's Enlarged Corporate Executive Committee. In this position, he oversees the development of new molecules to treat a variety of diseases (immunology, infectious diseases, ophthalmology, neuroscience, rare diseases, and oncology), spanning stages from target assessment to proof-of concept clinical trials. He obtained his MD and PhD degrees at Yale University, did his housestaff training in Internal Medicine at New York Presbyterian Hospital-Weill Cornell Campus, and completed his medical oncology and postdoctoral fellowship training at Memorial Sloan-Kettering Cancer Center (MSKCC). He joined the faculty at MSKCC and was eventually recruited to Vanderbilt, where he became Professor of Medicine, Director of the Division of Hematology/Oncology, and Director of Personalized Cancer Medicine at Vanderbilt-Ingram Cancer Center. During his academic career, his laboratory made seminal contributions to the understanding of molecular mechanisms of solid tumor pathogenesis. His work identified new molecular mechanisms of sensitivity and resistance of lung cancers to EGFR inhibitors, leading to new diagnostics and therapies for patients. His work helped change the standard of care in lung cancer. Prior to his current position, he was the Global Head of the Oncology Discovery and Translational Area (DTA) for pRED.

Bin Sheng was born in Beijing, P.R. of China. He graduated from Beijing University of Technology in material science and got his master degree at Columbia University. Most of his professional experience is based on investment in China, with a long history of network links with Financial Institutions and Swiss Innovation.
